X. DEPARTMENT REPORTS

A. Finance

C. Housing

1. Guardian Angels Discussion

Frick discussed how at the December 2021 meeting, the CDA board voted to enter into a letter of intent with Community Asset Development Group to purchase the Guardian Angels school building and convent for redevelopment. She said the church held a meeting in early January to discuss the sale. There are two groups interested in the sale, however, there is no purchase agreement or letter of intent by the church with either group. She said the church has three scenarios which they are looking at.

Frick said there seems to be confusion on the CDA's role as well as affordable housing in Carver County.

Koivumaki added she was in attendance at the meeting and provided additional details about the meeting. Her biggest concern was the decision at the meeting about whether there was enough affordable housing in Chaska and how other communities besides Chaska should be doing their part.

Carlson asked where we stand on out letter of intent with Community Asset Development Group? Frick said nothing at this time because they do not have a purchase agreement/letter of intent with the church.

Koivumaki said it seems like the CDA should send a response about the incorrect information given about the need for affordable housing in Carver County. Anderson Agreed.

Frick said there are a lot of discussions happening, so we will just need to be patient. It's in the church's hands to decide at this time.

Sudheimer requested a tour if the project moves forward.

D. Administrative

1. Streich provided an update on the hiring of a new Director of Housing.

XI. OTHER BUSINESS

- Koktavy provided a county update
 - o The first county board meeting of the year was their organizational meeting. Degler was elected chair and Fahey vice chair. Fahey was also voted to be the CDA liaison.
 - The board voted to provide ARPA funds to build out the fiber network. They will issue an RFP soon for telecoms to respond to in order to help with the build out.

XII. OTHER

- Kummer asked what the CDA's goals for affordable housing are in the county. Frick said to build on out existing property in Waconia and Carver first. There is a need for affordable housing beyond what the CDA can provide.
- Carlson said Streich has been out in the community sharing the work of the housing collaborative and asked if that presentation should be shared at a CDA board meeting. Streich said she was going to try and do it in February.
- Kummer asked if the CDA board ever has a meeting with the County Board. Frick said if there is financing that is needed for a project.
